TEXTBOOKS

INFUSION THERAPY MADE INCREDIBLY EASY.

This entry level book was recently updated. It is written for any clinician learning to administer infusion therapy and is not limited to nurses. This book has 10 chapters including a new chapter on biologic agents.

This is the original textbook on intravenous therapy, first published in 1970. As the practice has grown and expanded, so has this book. It contains 24 chapters from 21 contributing authors.

INTRAVENOUS MEDICATIONS

Authors Betty Gahart and Adrienne Nazareno

This is the most comprehensive resource for drug information when administered by the IV route, and includes hundreds of drug monographs Each monograph includes much needed information such as adult, pediatric and neonatal doses, dilution compatibility, rate of administration, actions, indications and contraindications, precautions, side effects, and antidotes in each monograph. This book is published annually and is a requirement for any nurse giving IV medications.

JOURNALS

Journals are a benefit of membership in each organization, however an individual or organizational subscription is available.

JOURNAL OF INFUSION NURSING (JIN)

This journal is now in its 40th year and is the official publication of the Infusion Nurses Society. It is published bi-monthly for 6 issues per year.

JOURNAL OF THE ASSOCIATION FOR VASCULAR ACCESS (JAVA)

This journal is published by the Association for Vascular Access and has 4 issues per year.

STANDARDS AND GUIDELINES

INFUSION THERAPY STANDARDS OF PRACTICE.

Authors – Lisa Gorski, Lynn Hadaway, Mary Hagle, Mary McGoldrick, Marsha Orr, and Darcy Doellman

This very important document is published as a supplement to the Journal of Infusion Nursing. It is revised every 5 years with the current document released in 2016. The next edition will be due in 2021. This document is included as a benefit of INS membership and can be purchased in printed and electronic format.

THE MICHIGAN APPROPRIATENESS GUIDE FOR INTRAVENOUS CATHETERS (MAGIC)

This document was created through a validated method of literature review and scenario assessment to provide guidelines on the appropriate use of PICCs and other types of vascular access. This can be downloaded without charge.

KIDNEY DIALYSIS OUTCOME QUALITY INITIATIVE. CLINICAL PRACTICE GUIDELINES AND CLINICAL PRACTICE

Recommendations: Vascular Access. 2006.

This is the definitive set of guidelines for use of all vascular access devices in patients with renal disease. Although it has not been updated in many years, it remains the primary source of guidance for this patient population

GUIDELINE FOR THE PREVENTION OF INTRAVASCULAR CATHETER-RELATED INFECTIONS. 2011, WITH EDITS FROM 2017

Authors - Naomi O'Grady, Mary Alexander, Lillian Burns, and others

This set of guidelines has been published periodically by the Centers for Disease Control since the 1970's. The process for its creation has changed through the years and is not changing again. The website has some revisions from 2017, however future documents will address specific practice issues in a more targeted manner.
